The bids will be opened in the presence of Bidders’ representatives who choose to attend at **13:00 pm** on 2077/06/29 (**15 October, 2020**) at the office of Rural Water Supply and Sanitation Fund Development Board, Maharajgunj, Kathmandu. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of as **mentioned above in the table for particular packages**, which shall be valid for 30 days beyond the validity period of the bid.

Bidders needs to submit the copy of Firm/Company Registration Certificate, VAT registration Certificate and permanent account number (PAN) registration certificate, Tax Clearance Certificate for FY 2075/76, business registration certificate and Self-declaration letter of not being ineligible up to the submission along with the bids as per BDS.
