The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 pm on 2077/07/02 (18 October, 2020) at the office of Rural Water Supply and Sanitation Fund Development Board, Maharajgunj, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of as mentioned above in the table for particular packages, which shall be valid for 30 days beyond the validity period of the bid.

Bidders needs to submit the copy of Firm/Company Registration Certificate, VAT registration Certificate and permanent account number (PAN) registration certificate, Tax Clearance Certificate for FY 2075/76, business registration certificate and Self-declaration letter of not being ineligible up to the submission along with the bids as per BDS.
