Invitation for Electronic Bids for the procurement of Supply, Delivery, Installation and commissioning of Chlorination System for Rural Water Supply Schemes

1. The GoN has received a credit. Grants (IDA 5446-NP/IDA H945-NP) from the International Development Association towards the cost of RWSSIP to apply part of funds to cover eligible payments under the contract for the procurement of Supply Delivery, Installation and Commissioning of Chlorination System for Rural Water Supply Schemes.
2. **Rural Water Supply and Sanitation Fund Development Board** ("the employer") invites **electronic bids** from Nepalese eligible bidders for the procurement of **Supply, Delivery, Installation and commissioning of Chlorination System** under National Competitive Bidding- single stage one envelope bidding procedures.

Bidders, submitting their bid electronically only, should deposit the cost of bidding document (payment of a non-refundable fee) of NRs 5,000.00 in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids through PPMO's e-GP system on or before **2077/12/18 (31 March, 2021) at 12:00 hours**.

4. Pre-bid meeting shall be held at **Rural Water Supply and Sanitation Fund Development Board Maharajgunj, Kathmandu** at **11:30 am** on **2077/12/08 (21 March, 2021)**.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 pm** on **2077/12/18 (31 March, 2021)** at the office of **Rural Water Supply and Sanitation Fund Development Board, Maharajgunj, Kathmandu**. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of as **mentioned above in the table**, which shall be valid for 30 days beyond the validity period of the bid (**i.e. till July 29, 2021**). In case of depositing bid security in cash please deposit at Rastriya Banijya Bank, Thamel Branch (Account No.: 1000200010000).
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

Bidders needs to submit the copy of Firm/Company Registration Certificate, VAT registration Certificate and permanent account number (PAN) registration certificate, Tax Clearance Certificate for FY 2076/77, business registration certificate and Self-declaration letter of not being ineligible up to the submission along with the bids as per BDS.
8. The Fund Board reserves the right to accept or reject, wholly or partly any or all the bids without stating any reason whatsoever.
